SPAR is a free service for all organizations within the Power Inn Alliance Property & **Business Improvement District (PBID)** – see map on reverse.

As a benefit to property and business owners, SPAR provides licensed security activated alarm response to cover the cost of activated alarm response calls.

- Relieves law enforcement from responding to false alarms.
- Prevents members from paying false alarm fines up to \$320 per call.
- A service report is provided upon investigation.
- No contract or term limit.


OPCON RESPONDS TO YOUR ACTIVATED ALARMS WITH THE SPAR PROGRAM
